Welcome (Liz Graham, President)

• Liz welcomed meeting participants and called the meeting to order

General Business/Announcements

- Minutes from last meeting a motion was made and carried to approve the minutes
- Treasurer's Report we have an additional membership; also, we have earned additional interest; motion made, seconded and unanimously carried to approve/accept the report
- LLAM Taxes Tanya filed our Maryland annual form; federal it seems that we should have been filing our federal returns, but haven't done so; we have lost our tax exempt status; Tanya consulted with Kevin Hughes; we will need to re-apply for tax exempt status; it may cost about \$400 - \$1,000; he promised to get back with referral information; in the interim Tanya checked into further professionals and obtained a list of 5 names of accountants who specialize in non-for-profits and tax-exempt status; would like to move forward with top choice to ask for a quote; Chi suggests preapproving \$1,000 to handle it; motion made, seconded and unanimously carried to approve/accept; this issue should not impact our liability insurance, but Liz/Rachel will check the AALL forum to see how others have approached similar experiences
- Frederick County Adult Detention Center Update by Jenna Joe reached out to Jenna; Joe was unexpectedly banned from his own library and from the detention center; books considered contraband; Joe allegedly did not use proper channels; Joe has requested a letter of support from LLAM; can we speak to the importance of the provision of in-person library services?;

Joe indicated to Jenna that he has operated in the same way for the last 9 years; all county materials removed from the library following Joe's ban from the library; follow-up contacts – Liz/UMd – Access to Justice, Carly/Ubalt – Access to Justice; Tanya/UMd – Kristen Moore follow-up
